

START: At intersection of 81st & Oak Park. 25' 10" south of stop sign at NW corner. 26' N of telephone pole at SW corner.

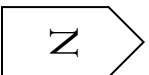
1 MILE: At sidewalk to 6145 - 81st and 6146 - 81st. 8' 8" E of snow route sign.

2 MILE: By school at middle of driveway. 6340 - 88th, 12' E of telephone pole F 6051.F.

3 MILE: At driveway 6740 - 81st, 9' 6" east of the mailbox.

FINISH: At stop sign at S exit of Burbank Park District parking lot. 13' 4" W of west edge at Newcastle.

1 MILE WALK: Will begin at the starting line, reach the half mile mark and end at the finish line.
